

ORDINANCE NO. 2016- 02

**AN ORDINANCE TO AMEND ORDINANCE 2010-12 - THE CODE OF ORDINANCES OF THE CITY OF PHENIX CITY, ALABAMA, CHAPTER 14, MOTOR VEHICLES AND TRAFFIC, ARTICLE I, IN GENERAL, SECTION 14-25, TRUCK ROUTE DESIGNATED.**

BE IT ORDAINED by the City Council of the City of Phenix City, Alabama that The Code of Ordinances of the City of Phenix City, Alabama, Chapter 14, Motor Vehicles and Traffic, Article I, In General, Section 14-25, Truck Route Designated is hereby amended to read as follows:

**Section 14-25. Truck route designated.**

(a) Motor trucks passing through the City must use the following route(s) hereby designated:

- Highway 80 west bound from the Alabama State Line in Phenix City to the intersection of Highway 280/431.
- 13<sup>th</sup> Street from the Alabama State Line in Phenix City to the intersection of 14<sup>th</sup> Street, to the intersection of Crawford Road, which then intersects Highway 280/431.
- Highway 80 west bound from the intersection of Highway 280/431 to the Police Jurisdiction.
- Highway 280 from the Oglethorpe Bridge North West to the Police Jurisdiction.
- Highway 431 southbound from the intersection of Highway 280 to the Police Jurisdiction.
- Brickyard Road from Colin Powell Parkway to Highway 165.

(b) No truck will be permitted for through traffic on Riverchase Drive, Summerville Road, Seale Road, and Broad Street, except for delivery purposes.

(c) Any person convicted of violation of this Ordinance in Municipal Court in Phenix City, Alabama shall be fined as provided for in Chapter I Section 8 of The Code of Ordinances of the City of Phenix City.

Any ordinance heretofore adopted by the City Council of the City of Phenix City, Alabama, which is in conflict with this ordinance is hereby repealed to the extent of such conflict.

If any part, section or subdivision of this ordinance shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this ordinance, which shall continue in full force and effect notwithstanding such holding.

This ordinance shall become effective upon its passage and publication as required by law.




