ORDINANCE NO. 2015-11

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF PHENIX CITY, ALABAMA, CHAPTER 12 GARBAGE, TRASH AND WEEDS, SECTION 12-2, RELATIVE TO FEES FOR THE COLLECTION OF GARBAGE, TRASH, AND WEEDS, SECTION 12-4.1, FEES FOR DUMPING AT INERT LANDFILL, AND SECTION 12-5.(A)-COLLECTION OF GRASS, LEAVES, TREE TRIMMINGS, APPLIANCES AND BULK ITEMS.

BE IT ORDAINED by the City Council of the City of Phenix City, Alabama, that the Code of Ordinances of the City of Phenix City, Chapter 12 – Garbage, Trash and Weeds, Section 12-2 – Relative to the Fees for the collection of Garbage, Trash and Weeds, Section 12-4.1, Fees for Dumping at inert Landfill, and Section 12-5(a) – Collection of Grass, Leaves, Tree Trimmings, Appliances and Bulk Items are hereby amended as follows:

SECTION 12.2. – Garbage and trash collection and disposal system established; frequency of collection; charges prescribed for collection.

- (a) There is hereby established in the city, a garbage and trash collection, hauling and disposal service to be operated by the city. The collection, hauling and disposal of garbage and trash shall be made by the officers, agents and employees of the city, under the direction of the City Manager of said city not less than one (1) time each week and the charges herein prescribed are based on such periodic collection and disposal.
- (b) Effective October 1, 2015 the following charges shall be collected by the City for the collecting, hauling and disposal of garbage and trash for each month.

(1) Residences (one-family in the city limits)
(2) Apartments and multifamily residences using garbage container, per unit or family
(3) Office buildings or professional buildings, per tenant \$ 27.00
(4) Mobile homes or trailer parks using garbage container, per trailer or mobile home
(5) Business or commercial establishments other than those listed above \$ 27.00
(6) Business or commercial establishments requiring bulk pickup service, in addition to the charges set forth above, per bulk pickup \$ 67.00

SECTION 12-5. Collection of grass, leaves, tree trimmings, yard waste, bulk items and construction debris.

(a) Containerized grass, leaves and yard waste not exceeding fifty (50) pounds in weight and tree trimmings and shrubbery cuttings not over six (6) feet in length or four (4) inches in diameter or fifty (50) pounds in weight and originating on private premises from which the sanitary department removes garbage and trash for a service charge as provided in this chapter, shall be placed in front of such premises for removal by the sanitary department without additional charge therefore; provided, however not more than one (1) twenty-cubic yard load per week shall be moved without charge on any one collection day. The charge for additional loads shall be one hundred ten dollars (\$110.00) per twenty-cubic-yard load or five dollars and fifty cents (\$5.50) per cubic yard. In times of emergencies such as storms, etc., the city council may waive the costs for additional loads.

This ordinance shall take effect October 1, 2015.

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

If any part of this ordinance is declared unconstitutional, it should not automatically void the remaining sections.
