

RESOLUTION NO. 2017- 135

WHEREAS, the City Council of the City of Phenix City, Alabama, has been informed by the Building Official of the City that a substandard structure located at 1035 4th Street South, Phenix City, Alabama, was in need of demolition or removal; and

WHEREAS, the City of Phenix City, Alabama, has solicited sealed bids as required by Alabama Law, and the apparent low bidder meeting the specifications required for the demolition of the substandard structure was Miles Excavating, the bid and dumping fees being \$ 3,197.85 and the demolition and final inspection being completed on the 4th day of April 2017; and

WHEREAS, the City is required by Law to give notice by certified or registered mail to the person last assessed for ad valorem taxes before the final fixing of costs and a copy of the Resolution is to be published in The Citizen of East Alabama, a newspaper of local and general publication in Russell County, Alabama; and

WHEREAS, the Building Official of the City of Phenix City, Alabama was authorized to proceed with the demolition and/or removal of the substandard structure with the apparent low bidder at the approved bid price.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Phenix City, Alabama as follows:

1. That the City Clerk give notice by certified or registered mail to the person last assessed for ad valorem taxes and a copy of this Resolution be published in The Citizen of East Alabama newspaper one time before the final fixing of costs and establishment of a special assessment upon the property as required by law.

2. That the date for fixing of costs before the City Council shall be July 3, 2017 at 3:00 PM in the Council Chambers at City Hall.


3. That at such public hearing any person interested in this property as well as the person last assessed for ad valorem taxes should appear and give reason, if any, why the City Council should not establish a special assessment upon the property for the cost of the demolition or removal of the substandard structure which the owner of the property had either failed or refused to do after it had become a public danger or health hazard.


4. The sum of \$ 3,197.85 shall be levied against the property located at 1035 4th Street South, Phenix City, Alabama as a special assessment and shall constitute a lien against the property to be collected through the Revenue Commissioner's Office for Russell County, Alabama. The Council notes that the parcel identification number of said property is 05-08-27-1-013-080.001#0.


5. Said parcel number 05-08-27-1-013-080.001#0 also contains structures at the following addresses: 1029, 1031, 1033, and 1037 4th Street South. Each of which have also been demolished and said special assessment for each has been placed against the property taxes for this parcel.

6. That the property owners as shown on the tax records of Russell County, Alabama is State of Alabama (2015 Tax), State Capital Bldg, Montgomery, AL 36104.

PUBLIC NOTICE


