AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF PHENIX CITY, ALABAMA.

Be it ordained by the City Council of the City of Phenix City:

Section 1: That the Zoning Ordinance of the City of Phenix City, Alabama, adopted on the 17th day of September, 2002 be amended so that the following tract of land be located in an C-1 Zone (Core Commercial District) instead of a R-3 Zone (High Density Residential District), property is located at 6th Avenue and 16th Street, The Housing Authority of Phenix City and The City of Phenix City, owners.

LEGAL DESCRIPTION

All that certain tract or parcel of land lying in Section 1, Township 17 North, Range 30 East, Phenix City, Russell County, Alabama, containing 27.9+/- acres, and being more particularly described as follows:
