AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF PHENIX CITY, ALABAMA.

Be it ordained by the City Council of the City of Phenix City:

Section 1: That the Zoning Ordinance of the City of Phenix City, Alabama, adopted on the 17th day of September, 2002 be amended so that the following tract of land be located in an A-1 Zone (Low Density Residential District and General Agricultural District) instead of a R-1 Zone (Low Density Residential District), property is located at 218 Wright Road, Dan and Jean Phillips, owners.

LEGAL DESCRIPTION

All that certain tract or parcel of land lying in Section 21, Township 17 North, Range 30 East, Phenix City, Russell County, Alabama, containing 7.12 acres and being more particularly described as follows:
