Section 1: That the Zoning Ordinance of the City of Phenix City, Alabama, adopted on the 17th day of September, 2002 be amended so that the following tract of land be located in an A-O (Apartment and Office District) instead of a No Zoning, property is 0.53+/- acres located on Waterworks Road, City of Phenix City owner.

LEGAL DESCRIPTION

All that certain tract or parcel of land located in Section 4, Township 17 North, Range 30 East, Phenix City, Russell County, Alabama, containing 0.53 acre and being more particularly described as follows:
