Be it ordained by the City Council of the City of Phenix City:

Section 1: That the Zoning Ordinance of the City of Phenix City, Alabama, adopted on the 17th day of September, 2002 be amended so that the following tract of land be located in a C-3 Zone (Neighborhood Commercial District) instead of a R-1 Zone (Low Density Residential District) property is 1.12+/- acres located at 5203 Summerville Road, Edward E. Cook, Jr., Roger D. Cook, Jeffery W. Cook and Tina M. Rogers, owners.

LEGAL DESCRIPTION

All that certain tract or parcel of land located in Section 28, Township 18 North, Rand 30 East, Lee County, Alabama, being Lot 6 and Part of Lot 7, Claude F. Pierce Property, as recorded in PB 5, PG 23A, in the office of the Judge of Probate of Lee County, Alabama containing 1.12 acres (48,750 sqft) and being more particularly described as follows:
