AN ORDINANCE TO AMEND CHAPTER 22 – ELECTIONS; SEC. 22-1 – DISTRICTS OF THE CITY; VOTING PLACES; (a) – DISTRICTS, BOUNDARIES ESTABLISHED; (1) – DISTRICT 1; (2) – DISTRICT 2; (3) – DISTRICT 3, OF THE CODE OF ORDINANCES OF THE CITY OF PHENIX CITY, ALABAMA.

WHEREAS, after receipt and review of the 2020 Federal Census Population Data that reapportionment is needed to comply with the City Charter Article VII, Section 7.03; and

WHEREAS, after review of the plans for reapportionment the City Manager recommends that the City Council of the City of Phenix City approve the Voting Districts described herein; and

WHEREAS, the City Council has considered the above reapportionment recommendation of the City Manager and is of the opinion that said City Manager’s plan be approved.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Phenix City, Alabama, that Chapter 22 – Elections; Sec. 22-1 – Districts of the city; voting places; (a) – Districts, boundaries established; (1) – District 1; (2) – District 2; (3) – District 3, of the CODE OF ORDINANCES of the City of Phenix City, Alabama is hereby amended to read as follows.

There shall be three (3) districts in the City of Phenix City, Alabama, and the boundaries thereof are hereby described as follows:

District One

All the land within the city limits lying North of the boundary line of District 1 and District 2, said line being more particularly described to wit:

Commencing at a point where the center line of 29th Street intersects the Alabama/Georgia State line, said point being the Point of Beginning of said boundary line; thence run West along the center line of 29th Street to a point where it intersects the centerline of 1st Avenue; thence run South along the center line of 1st Avenue to a point where it intersects the centerline of 25th Street; thence run West along the centerline of 25th Street to where it intersects the centerline of 8th Avenue; thence run North along 8th Ave to a point where it intersects the centerline of 26th Street; thence run West along the centerline of 26th Street to a point where it intersects the centerline of Summerville Road; thence run North Westerly along the center line of Summerville Road to a point where it intersects the center line of 12th Avenue; thence run South along the center line of 12th Avenue to the centerline of 28th Street; thence run West along the centerline of 28th Street to a point where it intersects the centerline of 15th Avenue; thence run North along the centerline of 15th Avenue to a point where it intersects the centerline of 28th Place; thence run West along the centerline of 28th Place to a point where it intersects the centerline of 16th Avenue; thence run South along the center line of 16th Avenue to a point where it intersects the centerline of 26th Avenue; thence run West along the centerline of 26th Street to a point where it intersects the centerline of 17th Avenue; thence run North along the centerline of 17th Avenue to a point where it intersects the centerline of Tradition Way; thence run West and Southwesterly along the centerline of Tradition Way to a point where it intersects the centerline of 19th Avenue; thence run Northwesterly along the centerline of 19th Avenue to a point where it intersects the centerline of Stadium Drive; thence run Southwesterly along the centerline of Stadium Drive to a point where it intersects the centerline of 21st Avenue; thence run North along the centerline of 21st Avenue to a point where it intersects the centerline of 27th Street; thence run West along the centerline of 27th Street to a point where it intersects the centerline of 22nd Avenue;

thence run Northeasterly along the centerline of 22nd Avenue to a point where it intersects the centerline of 28th Street; thence run West along the centerline of 28th Street to a point where it intersects the centerline of Norfolk Southern Railroad; thence run Northwesterly along the centerline of the said railroad to a point where it intersects the West line of the City Limits; said point being the Ending Point of said boundary line.

The voting place to be the Martin Idle Hour Park Community Center on Moon Lake Drive.

District Two

All the City land lying South of the boundary line of District 1 as described above and all the City land lying North of the boundary line of District 3 as described below.

The voting place to be the Central Activities Center on 14th Street.

District Three

All the land within the city limits lying South of the boundary line of District 2 and District 3, said line being more particularly described to wit:

Commencing at a point where the center line of Dillingham Street intersects the Alabama/Georgia State line said point being the Point of Beginning of said boundary line herein described; thence run West along the center line of Dillingham Street to a point where it intersects the center line of Broad Street; thence run South Westerly along the center line of Broad Street to a point where it intersects the center line of Martin Luther King Jr. Parkway; thence run Southwesterly along the center line of Martin Luther King Jr. Parkway being a divided highway to a point where it intersects the center line of U.S. Highway 280/431 bypass; thence run Northwesterly along the center line of U.S. Highway 280/431 to a point where it intersects the center line of Sandfort Road; thence run Southwesterly along the centerline of Sandfort Road to a point where it intersects the centerline of 7th Street; thence run Northwesterly and Westerly along the centerline of 7th Street to a point where it intersects the center line of 24th Avenue; thence run North along the centerline of 24th Avenue to a point where it intersects the centerline of 9th Street; thence run West along the centerline of 9th Street to a point where it intersects the centerline of 25th Avenue; thence run North along the centerline of 25th Avenue to a point where it intersects the Southwesterly right of way of Highway 280/431; thence run Northwesterly along said right of way to the Northeast corner of Census Block 1034, Block Group 1, Census Tract 306, Russell County, Alabama; thence run West along the North line of said Census Block to a point where it intersects the centerline of 28th Avenue; thence run Northerly along the centerline of 28th Avenue to a point where it intersects the centerline of U.S. Highway 80; thence run Westerly along the centerline of U.S. Highway 80 to a point where it intersects the West line of the City Limits; said point being the Ending Point of said boundary line.

The voting place to be the Calvin Spencer Recreation Center on South 8th Avenue.

BE IT FURTHER ORDAINED by the City Council of the City of Phenix City that the above described District boundaries, and designated voting places shall be used for future city elections conducted by the City of Phenix City. Subject to approval by the Justice Department.
