Garbage Collection Fee Ordinance

Based on the garbage collection contract with Waste Management (WM), the rate for collection may be revised based on the Consumer Price Index (CPI). WM informed us of garbage collection rate increases based on the Consumer Price Index (CPI) in 2021 and recently in 2024 which will increased the 2015 garbage collection contract price 20.84% in 2022 and will increase the contract price 6.67% this year.

The existing garbage fee ordinance (Ordinance No. 2022-01) needs to be amended to increase our garbage fees to match the increase of the garbage rate increase by Waste Management. I propose the rates be amended to reflect the same 20.84% and 6.67% increase from the 2015 fees which would increase the current rates for the first can from \$21.09 to \$23.72 and for additional cans from \$12.24 to \$14.76. The other fees are to be raised by the same percentages.

Waste Management requested residential rate increases based on the Consumer Price Index (CPI) which will increase the current rates by \$2.69 for the first can and \$0.79 for additional cans.

The existing garbage fee ordinance (Ordinance No. 2015-14) needs to be amended to increase our garbage fees to match the increase of the garbage rate increase by Waste Management. This would increase the rates for the first can from \$18.40 to \$21.09 and for additional cans from \$11.45 to \$12.24.

AN ORDINANCE TO AMEND ORDINANCE NO. 2015-11 OF THE CODE OF ORDINANCES OF THE CITY OF PHENIX CITY, ALABAMA, CHAPTER 12 GARBAGE, TRASH AND WEEDS, SECTION 12-2, RELATIVE TO FEES FOR THE COLLECTION OF GARBAGE.

BE IT ORDAINED by the City Council of the City of Phenix City, Alabama, Ordinance No. 2015-11 of the Code of Ordinances of the City of Phenix City, Chapter 12 – Garbage, Trash and Weeds, Section 12-2 – Relative to the Fees for the collection of Garbage is hereby amended as follows:

SECTION 12.2. – Garbage and trash collection and disposal system established; frequency of collection; charges prescribed for collection.

- (a) There is hereby established in the city, a garbage and trash collection, hauling and disposal service to be operated by the city. The collection, hauling and disposal of garbage and trash shall be made by the officers, agents and employees of the city, under the direction of the City Manager of said city not less than one (1) time each week and the charges herein prescribed are based on such periodic collection and disposal.
- (b) Effective February 1, 2016 the following charges shall be collected by the City for the collecting, hauling and disposal of garbage and trash for each month.

(1)	Residences (one-family in the city limits)
(2)	Apartments and multifamily residences using garbage container, per unit or family
(3)	Office buildings or professional buildings, per tenant \$ 27.00
(4)	Mobile homes or trailer parks using garbage container, per trailer or mobile home
(5)	Business or commercial establishments other than those listed above \$ 27.00
(6)	Business or commercial establishments requiring bulk pickup service, in addition to the charges set forth above, per bulk pickup \$ 67.00

This ordinance shall take effect February 1, 2016.

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

If any part of this ordinance is declared unconstitutional, it should not automatically void the remaining sections.
