# MEETING MINUTES August 5, 2025

The members of the City Council of the City of Phenix City, Alabama met in a regularly scheduled council meeting on Tuesday, August 5, 2025 at 9:00 a.m. at 1111 Broad Street, Phenix City, Alabama, 36867. Upon roll call, the following members of Council were present: Councilmember Arthur L. Day, Jr., Councilmember Vickey Carter Green, Councilmember Steve Bailey, Councilmember R. Griff Gordy, and Mayor Eddie N. Lowe. Also present were City Manager Wallace Hunter, Assistant City Manager Chan Gamble, City Attorney Jimmy Graham, and City Clerk Shannon Davis.

Upon a quorum being established, Mayor Lowe called the meeting to order.

Reverend Adrian Chester, Greater Bealwood Baptist Church delivered the invocation as it was listed on the agenda.

Councilmember Day led the Pledge of Allegiance to the United States Flag.

City Manager Wallace Hunter and Human Resources Director Stephaine Chastain presented employee service recognitions to Jennifer Lowman –15 years, Ms. Chastain stated that Diana Lynch - 5 years, Matt Johnston – 10 years were not able to attend.

Mayor Lowe presented a proclamation recognizing the Phenix City All Stars 8U Baseball Team World Series Champions.

Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Day, Green, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAINS: None. The motion thus passed.

Mayor Lowe presented for first reading an application for an Off-Premise Beer License and Off-Premise Wine License, submitted by Jaybajrang7 Inc., dba 7 Milestone located at 3881 US Highway 431 South, Phenix City, Alabama. Councilmember Green moved to place the applications on first reading, which motion was seconded by Councilmember Day. City Attorney Jimmy Graham presented a claim against the City of Phenix City, filed by Chuck Walton. Mr. Graham stated that on May 13, 2025 Mr. Walton's residence was damaged as a result of a failed sanitary sewer lift station located behind his home. Mr. Graham recommended approving the claim in the amount of \$8,918.75. Councilmember Day, moved to approve the City Attorney's recommendation to approve the claim in the amount of \$8,918.75, which motion was seconded by Councilmember Gordy. Which upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmember Day, Green, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAINS: None. The motion passed.

City Attorney Jimmy Graham presented a claim against the City of Phenix City, filed by Carter Manderson. Mr. Graham stated that on July 5, 2025 Mr. Manderson was riding his motorcycle when he hit a pothole in the roadway. Mr. Graham also stated that Mr. Manderson received property damage to the fork of his motorcycle. Mr. Graham further stated that under Alabama Law, the City has to have notice of the pothole to be held liable for the damage. Mr. Graham recommended denying the claim. Councilmember Gordy moved to approve the City Attorneys recommendation to deny the claim, which motion was seconded by Councilmember Bailey. Which upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Day, Green, Bailey, Gordy, and Mayor Lowe, NAYS: None. ABSTAINS: None. The motion passed.

City Attorney Jimmy Graham presented a claim against the City of Phenix City, filed by Michael Brown. Mr. Graham stated that this claim filed with the City of Phenix City, was referred to the Alabama Municipal Insurance Company for processing.

Mayor Lowe thanked the City Council and the City employees for all they do.

Councilmember Day encouraged all the Citizens to be mindful that School begins on Thursday, August 7, 2025 and to be watchful for all of our children at the bus stops.

Councilmember Green stated that she wanted to congratulate the Phenix City All State 8U Baseball Team World Series Champions. Councilmember Green also stated to be mindful of our school zone when school starts back. Councilmember Green thanked the Citizens of District Two for allowing her to be their Councilmember.

City Manager Wallace Hunter encouraged Council and the Citizens to watch the news for the changes happening within the Phenix City School System with their new Principal at the High School. Mr. Hunter stated that they have also made changes to the phone policy for the students. Mr. Hunter also stated that these changes are being made to try to keep the focus in the classroom.

Director of Engineering/Public Works Angel Moore stated that South Railroad Street will not be open before the start of school due to unfortunate weather conditions and that the date has been pushed back for the project. Ms. Moore also stated that they are trying to get all the areas of the grass cut in the City and asked for the citizens to be patient.

Councilmember Bailey stated that the City Workers is doing their best to keep the City clean and grass cut.

Director of Engineering/Public Works Angel Moore provided an update on Crowell Parks Subdivision. Ms. Moore stated that after the heavy rain, the drains remained clear.

Mayor Lowe stated that the City of Phenix City's workforce are doing the best they can to keep our City clean. Mayor Lowe also stated that the Council will continue to do the right thing and if a mistake is made, they will admit it, learn from it and try not to make the same mistake again.

Mayor Lowe thanked CCTV Beam for bringing the meeting to the Citizens of Phenix City.

There being no further business to address, the meeting thus adjourned until August 19, 2025.
