# MEETING MINUTES September 16, 2025

The members of the City Council of the City of Phenix City, Alabama met in a regularly scheduled Council Meeting on Wednesday, September 16, 2025 at 6:00 p.m. at the 5<sup>th</sup> Street Youth Center, 1601 5<sup>th</sup> Street South, Phenix City, Alabama, 36867. Upon roll call, the following members of Council were present: Councilmember Arthur L. Day, Jr., Councilmember Steve Bailey, Councilmember R. Griff Gordy, and Mayor Eddie N. Lowe. Councilmember Green was not present. Also present were City Manager Wallace Hunter, Assistant City Manager Chan Gamble, City Attorney Jimmy Graham Jr., and City Clerk Shannon Davis.

Upon a quorum being established, Mayor Lowe called the meeting to order.

Mayor Lowe called upon Reverend Jacquelyn Bowie Hayter, Nichols Chapel AME Church to deliver the invocation as listed on the Agenda.

Councilmember Day led the Pledge of Allegiance to the United States Flag.

Mayor Lowe presented the meeting minutes of the July 16, 2025 Budget Work Session Meeting for approval. Councilmember Day moved to approve the minutes, which motion was seconded by Councilmember Gordy. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmember Day, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAINS: The motion thus passed.

Mayor Lowe presented the meeting minutes of the July 31, 2025 Budget Public Hearing Meeting for approval. Mayor Lowe presented an opening on the Phenix City Housing Authority Board. Councilmember Gordy moved to appoint Rudy Barraca, which motion was seconded by Councilmember Bailey. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmember Day, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAINS: None. The motion thus passed.

Mayor Lowe presented an opening on the Personnel Review Board. Councilmember Day moved to reappoint Johnny R. Rutledge, which motion was seconded by Councilmember Bailey. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmember Day, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAINS: None. The motion thus passed.

Mayor Lowe presented an opening on the Personnel Review Board. Mayor Lowe stated that current member; Jason Johnson is willing to serve another term. Mayor Lowe called for a motion. Councilmember Day moved to appoint Jason Johnson, which motion was seconded by Councilmember Gordy. Upon said motion being put to a vote, following vote was recorded: YEAS: Councilmember Day, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAINS: None. The motion thus passed.

City Attorney Jimmy Graham presented a claim against the City of Phenix City, filed by Anneque Milner. Mr. Graham stated that the claim alleges that the City of Phenix City is responsible for damages to the car door and rear tire of the passenger side of a 2023 Toyota Camry. Mr. Graham also stated that the claim states that the claimant was waiting to turn into a parking space when a City vehicle backed into her car. Mr. Graham recommended approving the claim in the lowest amount of \$4,211.45. Councilmember Gordy, moved to approve the City Attorney's recommendation to approve the claim in the estimate amount of \$4,211.45, which motion was seconded by Councilmember Bailey. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmember Day, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAINS: None. The Motion thus passed.

City Attorney Jimmy Graham presented a claim against the City of Phenix City, filed by Victoria Boss. Mr. Graham stated that a Utilities Department employee who was driving a truck was involved in a traffic accident at the intersection of US Highway 80 and US Highway 280 on August 14, 2025. Mr. Graham stated there were several scratches and some damage on the rear of the car, which do not appear to have been cause by the City truck, the police report notes there were no injuries reported. Mr. Graham further stated that based on the current information, it is not clear that the traffic accident caused enough damage to the car to require replacement of the rear bumper. Mr. Graham recommended denying the claim. Councilmember Gordy moved to approve the City Attorney's recommendation to deny the claim, which motion was seconded by Councilmember Bailey. Upon said motion being put to a vote, the following vote was recorded: YEAS: Councilmembers Day, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAINS: None. The motion thus passed.

City Attorney Jimmy Graham presented a claim against the City of Phenix City, filed by April Nicholson. Mr. Graham stated that the claim alleges that City of Phenix City is responsible for the damages to her driveway at her home that was damaged due to the water leak and water company and the garbage trucks driving over it. Mr. Graham also stated that the Utilities Department repaired leaks at this location on February 7, 2024 and August 7, 2025, the hydrant was also leaking and is currently out of service. Mr. Graham further stated that the driveway cracks at the road were present prior to the leak, and the cracks off of the road appear to have been damaged by a vehicle driving on the driveway. Mr. Graham stated based on the current information, the City is not responsible for repairing this driveway. Mr. Graham recommended denying the claim. Councilmember Day moved to approve the City Attorney's recommendation to deny the claim, which motion was seconded by Councilmember Bailey. Upon said motion being put to a vote, the following vote was recorded: YEAS Councilmember Day, Bailey, Gordy, and Mayor Lowe. NAYS: None. ABSTAINS: None. The motion thus passed.

Mayor Lowe presented a resolution in reference to authorizing and directing the Mayor and City Manager to hire Warr Grading Contractor, Inc., to replace the sanitary sewer main crossing Mill Creek near 16<sup>th</sup> Place in an amount not to exceed \$111,506.00.
