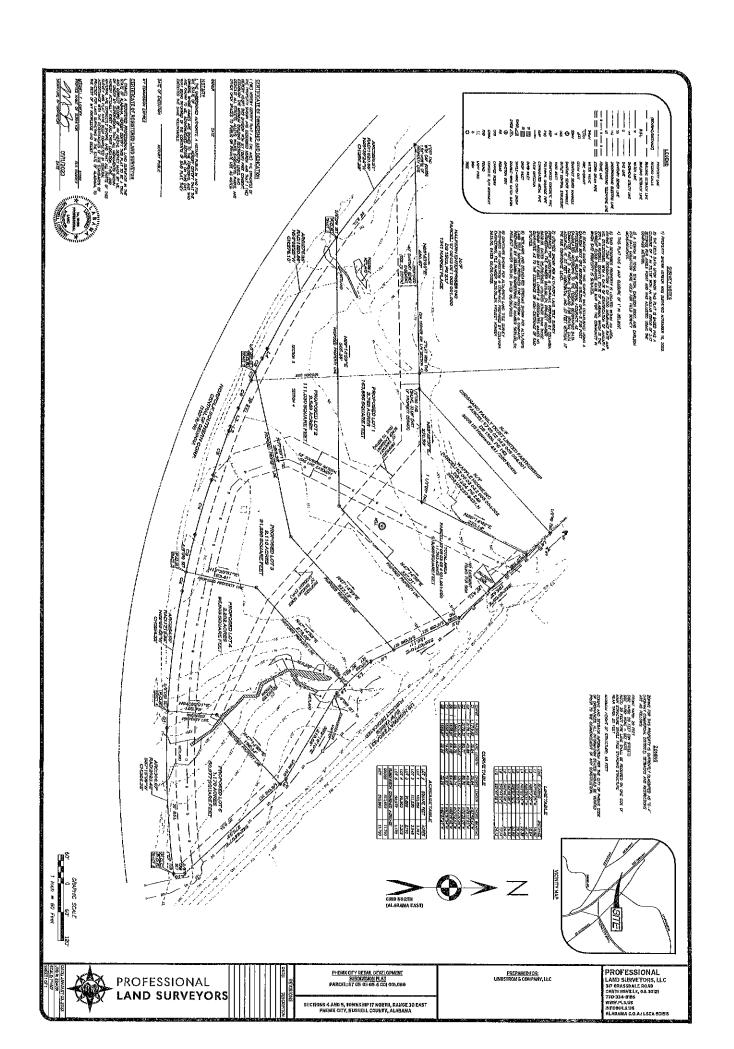

Commencing at a 1 inch crimped top pipe found at the southern end of the mitered intersection of the southwesterly right of way of U.S. Highway 280 (having a variable width, publicly dedicated right of way) and the northerly right of way of Norfolk Southern Corp (having a 100 foot right of way), said 1 inch crimped top pipe being the TRUE POINT OF BEGINNING.
